

GRADUATE CERTIFICATE IN NONPROFIT MANAGEMENT

The graduate certificate in nonprofit management provides an overview of central concepts in managing nonprofit organizations and is intended to meet the needs of students seeking a focused experience in preparation for a career in nonprofit organizations. It may be appropriate for students who seek to expand their knowledge but who do not wish to commit to a master's degree program.

Certificate students enroll in regular courses of the Trachtenberg School of Public Policy and Public Administration, which carry graduate credit. Regular graduate tuition and fees apply. Under certain circumstances, credit earned in the certificate program also may be applied toward the master of public administration (<http://bulletin.gwu.edu/arts-sciences/public-policy-administration/dual-mpa-and-nonprofit-management-gc/>) (MPA) degree or master of public policy (<http://bulletin.gwu.edu/arts-sciences/public-policy-administration/dual-mpp-nonprofit-management/>) (MPP) degree. However, admission to the MPA or MPP degree program has separate requirements from those of the certificate program and students considering going on for a degree should consult with a faculty advisor early in their program.

ADMISSIONS

Prior academic records:	Transcripts are required from all colleges and universities attended, whether or not credit was earned, the program was completed, or the credit appears as transfer credit on another transcript. Unofficial transcripts from all colleges and universities attended must be uploaded to your online application. Official transcripts are required only of applicants who are offered admission. If transcripts are in a language other than English, English language translations must be provided. The English translation alone should be uploaded into your application.

Statement of purpose: This is your opportunity to convey to the admissions committee whatever information about yourself – over and above the information provided elsewhere in your application (including your résumé) – that you would like them to consider.
In an essay of 250–500 words, state your purpose in undertaking graduate study in your chosen field. Include your academic objectives, research interests and career plans. Also discuss your related qualifications including collegiate, professional and community activities as well as any other substantial accomplishments not already mentioned on the application or résumé/curriculum vita.
