The program is designed for students who intend to develop skills in policy research and program evaluation. Emphasis is placed on developing both an understanding of the political and social environments affecting education policy; and the competencies needed to assess and analyze alternative policy potentials, their implementation, and their impact. The 36-credit program includes 12 elective course credits through which students develop expertise in a specific area of interest by engaging in applied policy analysis and/or interning at various research and policy institutions in the greater Washington, DC area.
