The University offers financial assistance to all eligible students from various resources. In addition to GW assistance, the University participates in federal student assistance programs from the U.S. Department of Education and student financial assistance programs from other U.S. government agencies such as the U.S. Department of Veterans Affairs and the U.S. Department of Defense. Some states offer student financial assistance for undergraduate enrollment at GW.

The Office of Student Financial Assistance (https://financialaid.gwu.edu/assistance-types/) (OSFA) administers financial assistance to both undergraduate and graduate students. Complete information concerning student financial assistance is available on the OSFA website.

Professional students enrolled in the Law School (https://www.law.gwu.edu/financial-aid/) or MD candidates in the School of Medicine and Health Sciences (http://smhs.gwu.edu/finaid/) should contact their respective financial assistance offices; all other students in the School of Medicine and Health Sciences should seek information and follow the procedure on the OSFA (https://financialaid.gwu.edu/assistance-types/) website for filing financial assistance application materials

The University's Office of Graduate Student Assistantships and Fellowships (https://www.gwu.edu/~fellows/) is specifically for graduate students in master's or PhD programs. The Office of Student Financial Assistance assists in the administration and certification of educational loans to meet the cost of attendance.

In general, consideration for student financial assistance is restricted to students in good academic standing at the University who meet minimum grade-point average and satisfactory academic progress requirements for specific awards and who are not financially encumbered by any other University office. Failure to meet and maintain satisfactory academic progress requirements may result in rescinding of awards.

Eligibility for student assistance is processed under cost of attendance budgets for various categories of students, per federal statutory requirements. Refer to the policy on cost of attendance budgets (http://financialaid.gwu.edu/cost-of-attendance/) on the OFSA website for details. A complete student assistance package cannot exceed a student's cost of attendance budget. GW will

review and potentially adjust awards for students receiving student financial assistance from more than one source. Receipt of student financial assistance from multiple sources cannot exceed tuition charges. If institutional assistance is involved, adjustments are made.

GW reserves the right to request documentation to determine assistance eligibility. Documents submitted as part of the assistance application become the property of the University and cannot be returned. Such documents are protected under the Family Educational Rights and Privacy Act (FERPA), as amended. GW policy concerning the privacy of student records is available from the Office of Ethics, Compliance, and Privacy (https://compliance.gwu.edu/privacy-student-records/).

Privacy of Student Records

Role of the National Student Loan Data System (NSLDS)

The National Student Loan Data System (NSLDS) is the national database of information about loans and grants awarded to students under Title IV of the Higher Education Act (HEA) of 1965. NSLDS provides a centralized, integrated view of Title IV loans and grants during their complete life cycle, from aid approval through disbursement, repayment, deferment, delinquency, and closure. Data on federal student loans and Federal Pell Grants are reported to the NSLDS, which is accessible by GW and U.S. Department of Education personnel and servicers of federal student loans. Students can access their data on the NSLDS website (https://nsldsfap.ed.gov/).

Title IV Funds

Title IV funds are federal student aid funds, which are from federal student aid programs administered by the U.S. Department of Education. Title IV funds include Direct Subsidized/Unsubsidized Loan, Direct Graduate PLUS Loan, Direct PLUS Loan, Federal Pell Grant, Federal Supplemental Educational Opportunity Grant (SEOG), Federal Perkins Loan, and TEACH grants. It does not include scholarships from the University or other private organizations.
