DOCTOR OF PHYSICAL THERAPY

The doctor of physical therapy program reflects the mission of GW's School of Medicine and Health Sciences, which includes teaching with creativity and dedication; healing with quality and compassion; and discovering with imagination and innovation. This is an entry-level professional program that prepares graduates to examine, evaluate, diagnose, develop plans of care, provide interventions, and assess outcomes for patients with a wide range of musculoskeletal, neuromotor, cardiopulmonary, and integumentary dysfunctions. The program is offered full-time over eight semesters.

Students explore the legal and ethical aspects of patient care as well as issues of communication, patient education, health promotion, health policy, and practice management. The program is committed to the development of generalist practitioners prepared to practice in an evidence-based and ethical manner. Graduates are reflective practitioners who think critically to effectively solve problems; compassionate practitioners who demonstrate excellence in communication and interpersonal skills with respect for individual and cultural differences, and the core values of the profession; and dedicated practitioners who value the tenets of lifelong learning. Small classes enable students to engage in critical thinking activities that facilitate effective clinical decision making and problem solving. Faculty members use innovative teaching strategies and integrate clinical experiences to facilitate learning and retention throughout the curriculum.

This program is accredited by the Commission on the Accreditation of Physical Therapy Education of the American Physical Therapy Association. Students are eligible to sit for the national licensing examination upon graduation.

ADMISSIONS

Admission deadlines: Fall - December 1

The application and all supporting documentation (fees, statement of purpose, letters of recommendation, transcripts, test scores) must be received by the deadline in order for the application to be reviewed.

The Doctor of Physical Therapy Program uses the online application system PTCAS (Physical Therapist Centralized Application Service). Please go to the PTCAS website: (https://ptcas.liaisoncas.com/ applicant-ux/#/login) to begin the application process. The fee for using PTCAS is based on the number of programs the applicant designates. A limited number of application fee waivers are available. Meeting PTCAS' eligibility criterion for a fee waiver does not guarantee a waiver will be granted for supplemental application fees.

In addition to the PTCAS application, all applicants must submit a GW Supplemental Application to the Health Sciences Office of Admissions.

Standardized The GRE is optional. If applicants choose to report test scores: GRE scores, please do so by the application deadline. The institution code for GW is 5246.

Recommendations must be submitted with required: your PTCAS application.

Prior academic records:

Official transcripts from every college and university attended must be submitted directly to PTCAS. All transcripts must be submitted, whether or not a

degree was earned.

All non-U.S. transcripts (including those in English) must be evaluated by World Education Services and submitted directly to PTCAS.

Statement of In an essay of 250 to 500 words, describe your purpose:

reasons for undertaking study in the Doctor of Physical Therapy Program at The George Washington University. You should state your academic objectives, career plans, and related qualifications, including collegiate, professional, and community activities, as well as any other substantial accomplishments related to leadership and/or advocacy and any others not already mentioned on the application form.

Additional Applicants to the program must have a bachelor's Requirements degree from an accredited institution.

Prerequisite course work includes the following:

- -Anatomy and Physiology (two semester sequence, or one semester of each; human focus preferred)
- -Physics (two semesters with lab)
- -Chemistry (two semesters with lab)
- -Biology (two semesters with lab recommended)
- -English (one semester: composition or literature)
- -Statistics (one semester; mathematical focus preferred)
- -Psychology (two semesters: must include psychology beyond the introductory level)

All science courses must be for science/health science majors.

All applicants are required to review the Technical Standards/Essential Functions for the Doctor of Physical Therapy Program and the Criminal Background Check and Drug Screening Policy before applying.

Note: Accepted applicants will be required to pay a non-refundable tuition deposit.

Students:

International International students should check with individual programs regarding eligibility for visa sponsorship. Generally, online and hybrid programs are not eligible for student visa sponsorship from GW. This would include transfer students from any other institution with an existing visa.

Doctor of Physical Therapy

Official transcripts from institutions outside the U.S. must be accompanied by an official transcript evaluation from an accredited independent evaluating agency. Please be sure you request a detailed evaluation that includes all course titles, credit hours, grades, U.S. degree equivalency, gradepoint averages (GPA), and date of degree conferral. Applicants who are not U.S. citizens are required to submit official test scores for either Test of English as a Foreign Language (TOEFL) or#Pearsons#Test of English (PTE), Academic the academic International English Language Testing System (IELTS) or the Duolingo English Test (DET). The following are the minimum scores for admission consideration:#TOEFL: 600 on paper based, 250 on computer-based, or 100 Internet-based, PTE: overall score of 68, IELTS: an overall band score of 7.0, with no individual band score below 6.0, or DET overall score of 120. *Scores can be no older than 2 years.

International applicants who meet the following conditions may be considered for admission without submitting TOEFL, PTE or IELTS or DET scores:#They are a citizen of countries where English is the official language (as identified by GW ISO list of Exempt countries) OR; They hold at least a#bachelor#degree from a country where English is the official language as well as language of instruction OR; They hold at least a#bachelor#degree from an institution accredited by a U.S. regional accrediting agency.
